

Main problem: «What to do?»

Field of application:

The guaranteed market;


Constantly increasing demand.

Advantages:

- Simplicity;
- Replicating.

Disadvantages:

- It is insolvent in the conditions of competitive struggle;
- Expectations and requirements of clients aren't considered.



Functional approach to management

Contradictions:

At strengthening of the environment factors influence on the enterprise it is INADMISSIBLE speed of the organizational structure response decreases.

Inventive principles:

- Another Dimension;
- Mechanical Principle Replacement.

Process approach to management

Main problem: «How to do?»

Field of application:

- The rather slowly changing market;
- The companies of the average and big size.

Advantages:

- Fast reaction to change of external conditions;
- Orientation on the client;
- Focusing on quality improvement.

Disadvantages:

- More difficult control system;
- Not possible effectively to operate projects.





Process approach to management




Contradictions:

At increase cross-interaction between business processes it is INADMISSIBLE the business management efficiency decreases.

Inventive principles:

- Dynamicity;
- Feedback.

Field of application:

- The worldwide market;
- The huge companies.




Advantages:

- Debureaucratization of the administrative organizations.




Business model

The Key Criteria of Living Systems






- pattern of organization is a set of relations specifying essential characteristics of a system;

Actually business process operating at the enterprise


