

# Strategy of the development of the business of Republic of Korea


Republic of Korea is the country with actively developing economy and the perspective purposes in many directions:


TRIZ successfully apply in the large South Korean companies such as: SAMSUNG, LG, POSCO, Hynix Semiconductor, SKT, etc.





# Strategy of the development of the business of Republic of Korea

With a view of TRIZ introduction in this sphere of business «Ministry of Knowledge Economy» of South Korea for the first time has organized pilot TRIZ-project











- 1 In KPU the infrastructure of assistance to the enterprises of small and medium business is developed.
- 2 At the university works «Korea-Russia Industrial Technology Cooperation Centre» (further KRITCC).
- 3 KRITCC has incurred responsibility for the organization and TRIZ-project realization.



In KRITCC the procedures of interaction with the companies-customers have been developed. For example, the cooperation agreement providing following articles:

- The purpose of the agreement,
- The maintenance and limits of the project,
- Terms of the project,
- Financing of the project,
- Duties of the parties,
- Confidentiality,
- The reporting, the intellectual rights,
- Modification, cancellation of the agreement,
- The beginning of action of the agreement





The experimental stage **«TRIZ-practice»** started on **February, 26th, 2009** when the first meeting of TRIZ-experts with representatives of one of the Korean companies-customers has taken place













In June 2009 the second part of a stage «TRIZ-practice» in which 5 companies of small and medium business of city Incheon – one of the large industrial centers of Republic of Korea take part has begun.























# 3. Features of realization of a stage «TRIZ-practice»




















In the official responses the Korean companies-customers mark following results of teamwork with TRIZ-experts.










• TRIZ interests the personnel in the decision of industrial problems and allows workers to overcome earlier existing stereotypes of concrete owners of technological processes.


- TRIZ creates conditions for innovative thinking.
